Paddle Florida Policies:

1. All paddlers must attend the pre-launch safety briefing. Paddlers must adhere to the safety guidelines presented.
 2. Paddlers must wear a properly fitted U.S. Coast Guard approved personal flotation device at all times on the river.
 3. Paddlers under age 18 are the responsibility of, and must be accompanied by, a parent or guardian.
 4. Sorry, no pets allowed.
 5. All paddlers must sign a Medical and Emergency Contact Information sheet and a Waiver of Claims and Release of Liability form. Parents must sign for children under the age of 18. These forms are available on the web site.
 6. People-powered watercraft only.
 7. No alcoholic beverages will be allowed.
 8. All paddlers must respect private property along the river.
 9. All paddlers must have basic paddling and swimming skills.
 10. No more than 2 children under the age of 12 per adult guardian.
 11. Violations of these policies can result in the paddler being removed from the event without refund.
- 12. Refund Policy:** No refunds within two weeks of start date. Refunds will be considered on a case-by-case basis.
